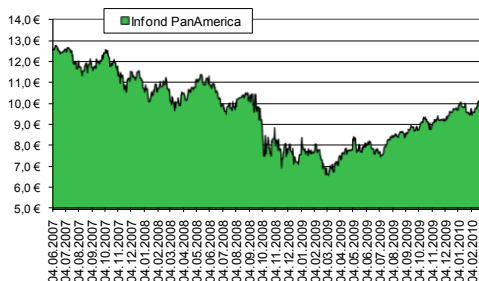

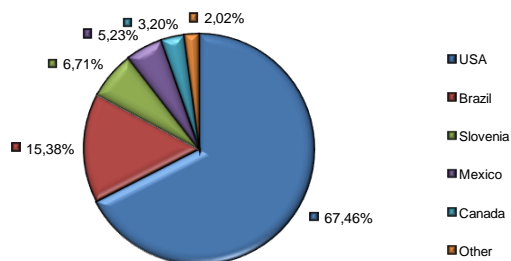

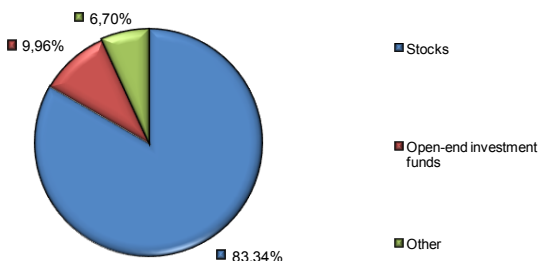

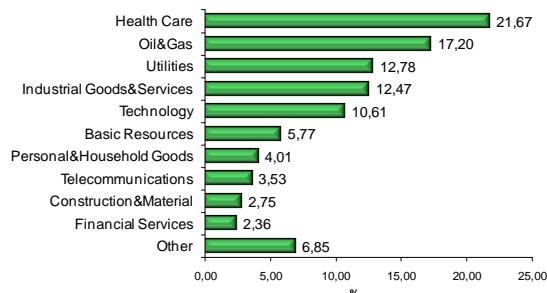
Fund Performance from 4th June 2007 till 26th February 2010
